\*National Textile Corporation has 7 mills in Tamil Nadu, 4 Mills in Kerala, 1 Mill in Mahe (Puducherry UT), 5 Mills in Maharashtra, 2 Mills in Madhya Pradesh, 1 Mill in Gujarat, 1 Mill in Karnataka, 1 Mill in Andhra Pradesh, 1 Mill in West Bengal, 2 Regional Offices Mumbai and Coimbatore, Sub Office at Kanpur, Divisional Office at Delhi and Head Office at New Delhi. However, the positions are transferable across India.

**1. COMPENSATION PACKAGE:**

In addition to basic pay of the Pay Scale, the Executives are also entitled to Dearness Allowance on IDA pattern, Company accommodation if available or HRA, Conveyance allowance as applicable from time to time. **2. EDUCATIONAL QUALIFICATION**

The qualification which qualifies the candidate should be from recognized universities/institutes under the full time/regular scheme only.

**3. GENERAL CONDITIONS:**

- (1) Only Indian Nationals need apply.
- (2) Appointment to the posts will be on regular basis. Initially selected candidates will be engaged for a period of 6 months training in the regular pay scale of Rs 12600-32500/- (IDA) and on successful completion of training period they may be placed in the position of Assistant Manager in the same pay scale of Rs 12600-32500/- on probation for a period of one year. The training period will be subject to extension, in the event of not attaining desired performance level.
- (3) Selected candidates during the period of his/her employment will be required to serve at any location/office of NTC situated across India.
- (4) NTC will not be responsible for any postal delay/ wrong delivery/ non-delivery of communication by the candidate at any stage of the recruitment process.
- (5) The cutoff date for considering the age of candidates will be taken as on **30.06.2017**.

**For Management Trainee (Textile)**, Candidates qualified in corresponding paper of **GATE – 2017** i.e. Textile Engineering & Fibre Science (TF) shall only be eligible. Based on the merit of the **GATE Score**, selection will be made without any further interview process.

**For Management Trainee (Finance)**, Candidates qualified in **CA/CMA** shall only be eligible. Based on the **Percentage of Marks** secured in the qualification, selection will be made without any further interview process.

5. Depending on the response of the candidates, management will prepare a merit list on the basis of **GATE Score** for Management Trainee (Textile) and Percentage of Marks secured in **CA/ICWA** for Management Trainee (Finance). Based on the Merit List/ Panel prepared so, the candidates shall issued offer as per the requirement from time to time.
