2. Parties are advised to visit the mills for physical inspection of the Scraps. The quotation shall be deemed to have been submitted by the party with full knowledge about the actual condition of the material and no complaints will be entertained after submission of tender.
3. Rates are to be quoted separately for each item as per prescribed unit only Rate quoted should be Exclusive of all Taxes. ( i.e. Taxes extra) & Ex-mill.
4. Offers must be submitted on our format only. Conditional tenders are likely to be rejected.
5. Every offer shall be accompanied by an earnest money/security deposit by demand draft/pay order only on other than Co-op Bank drawn in favour of “RAJNAGAR TEXTILE MILL”. Quotations received without EMD shall be rejected. Earnest Money Deposit will be converted into Security Deposit in case of successful tenderer and will be adjusted against the last transaction of the tender. E.M.D. will not carry any interest.
6. The party, whom the material is sold, shall have to deposit entire value by cash/DD on same day before material get out mill, failing which the entire amount of Earnest Money Deposit received against the tender, irrespective of item offered, shall stand forfeited.
7. In case, party fails to execute any one or all sale contracts issued to them or any part thereof the entire amount of Earnest Money Deposit paid shall stand forfeited.
8. The buyer shall lift the material within 7 days from the date on which advice to lift material.
9. Wherever the sale is on weight basis, it should be weighted on Weigh Bridge of the mills. Weighment shall be done in presence of mill representative and Weighment slip shall be signed by both party and mill representative.
10. All Taxes/Levies/It prevailing on the day of delivery will be payable extra. Parties will have to deposit Income Tax on total sale value at prevailing rate. Please mention **GST** Number .
11. The purchaser shall be responsible for all damages caused to Mill Property and personnel in course of removal of material, In case of damage cost will be recovered.
