**Terms and Conditions for the appointment of parties for mill units under NTC Ltd., for aforesaid e-sale of fabric and loom programme through e-offer.**

1. **Consideration of Appointment :**

Appointment will be made strictly on merits considering the following factors :

- A) Experience in the relevant filed.
- B) Reputation in the Textile Market.
- C) Financial soundness of Party.
- D) Past performance of the other mills.
- E) Membership of trade association.

2. **Validity of appointment:**

Appointment will be made initially for one year and will be renewed every year only after reviewing their performance during the period. Appointed Agency has to enter into agreement with the mills

3. **Security Deposit and Interest thereof:**

Appointed Agency for each mill will have to pay security deposit of Rs.2.00 Lacs per mill. The Security Deposit will carry simple Bank Interest at the rate prescribed by State Bank of India for fixed deposit for one year.

4. **Sale of Cloth:**

- a. The appointed agency will have to bid in the e-offers and give offers for 90 days or as decided by the management from time to time, in advance quality wise, sort wise.
- b. For the contract awarded to them the successful bidder will have to deposit 5% of the total value as advance at the time of signing the contract which will be adjusted against the last delivery of the contracted fabric.
- c. Mill will be bound to give delivery of bales, which has been accepted by the mills in writing only given after rates are increased in between.
- d. However, if bidding agency doesn't take delivery of contracted bales which they have contracted in such cases penalty @2.5% of value of the unlifted goods will be levied for non lifting of bales.
- e. In case of default in the contract by the agency the corporation reserves the right to sell the goods in open market and recover the loss from the bidding agencies pending dues and/or the security deposit

5. **Market reports:**

Agency appointed will give constant feed back to the mills as regards the quality of products. They will also give feedback regarding competitor's quality that is in demand alongwith their samples and prices. This should help to increase the turnover between appointed Agency and Mills.

6. **Payment terms:**

All deliveries are against payment by Drafts or after realization of cheque.

7. **Commission:**

The appointed agency shall be entitled to get the commission on Ex-mill value of invoice at the rates not exceeding as under.

Description	% of commission on Ex-mill value
All grey fabrics (Cotton / Synthetic)	1.50
All processed (Cotton / Synthetic)	2.00

8. **Conditions for payment of commission:**

- a) The commission shall be paid on monthly basis will be released by 7<sup>th</sup> of every month on Ex-mill value only on fully paid invoice and /or on completion of the contracted sale.
- b) The mill will not charge any expenses to the buyer for passing on the same to the Indenting Agents. All expenses incurred on this behalf shall be payable by the buyer or the Agent immediately.
- c) All incidental charges such as overdue interest, Bank commission, demurrage, shortage etc. not paid by the dealer will be recovered /adjusted from the appointed Agencies commission immediately.

10. **Claim:**

The appointed agency shall be bound to perform their respective obligation within the Specified time limits. In case the claim against the defective quality of goods, the same shall be lodged with the mill within 30 days from taking delivery of the goods, failing which the claim shall not be entertained by the mills.

11. **Force majeure:**

The appointed Agency shall absolve the mill from performing the contractual obligations if the mill is unable to fulfill the same due to the reason beyond the control of the mills.

12. **Other Duties and Taxes:**

At present there is no Excise Duty for Cloth sales, however any other Duties and Taxes levied by the Government at time of delivery will be charged extra. Service Tax will be payable by the parties and reimbursed by the units, as ruling from time to time.

13. **Management Rights:**

Management reserves the right to reject the application without assigning any reason.

14. Termination:

The appointed agencies right to participate in the e-offers will be terminated by giving notice of 30 days from either side.

15. Jurisdiction:

The transactions and disputes arising out of the contracts entered between the appointed agency and mills shall be subject to the court Jurisdiction of Mumbai in case of units under NTC WRO and Coimbatore in case of units under NTC SRO, as the case may be.
