#### TERMS AND CONDITIONS FOR DISPOSAL OF DEBRIS FROM MILL.

- 1) My offer are not ex. your mills applicable taxes, will be paid by me extra including excise duty if applicable for item.
- 2) On acceptance of may offer I shall pay Rs. 1000/- deposit which will be kept with the mills till the last delivery of sold out articles in line with the terms and conditions of the contract to the mills satisfaction.
- 3) I shall clear the accumulations on the dates fixed by you as above and the clearance will be made on the ENTIRE LOT ON CLEAN SWEEP BASIS of found accumulation on the day of clearance subject to condition No. 5.
- 4) I shall clear the material in the condition in which is stands and shall not claim any compensation adjustment set off or deduction in the advance amount paid by me as per the contract at any time.
- 5) I shall have no claim on whatsoever articles or articles which you will may retain or keep back (for their own use) from the material for delivery as per the contract at any stage of contract or even at the stage of delivery.
- 6) In case I fail to fulfill the terms of the contract I agree to the conditions that the entire amount standing to my credit in your books including security deposit shall be forfeited by you.
- 7) I shall take the delivery of scrap/sundry articles without damaging mills property and in case of damage cost may be recovered from me.
- 8) In case where the sale order is a contract for curtain period of time I shall clear all the accumulation before the expiry of contract, as well whenever needed by mills during the contract in case of failing to fulfill the contract in a contract period I agree to pay 2% interest and 2% penalty on sale value of mill is ready to deliver the scrap in time which mill feels reasonable.
