It is desired to dispose of by tender the stock of Chindis as detailed in the attached form of tender. You may submit your offer in a sealed cover by completing the enclosed tender in all respects and duly signed under rubber stamp of the tenderer. The tender may be deposited in the tender box kept at the mills premises mentioned above or be sent by post so as to reach us not later than 5.00P.M. on 31 / 10 /2018.

The tender will be subject to the following terms and conditions and also the terms and conditions mentioned in the enclosed tender.

1. The tender is to be submitted so as to reach the mills latest by 5.00P.M. on 31 /10/ 2018.Any tender received after the closing time is liable to be rejected.
2. The tender should be legibly written and should be filled in ink without any erasing and overwriting. A correction can be made by scoring out the original matter and writing the correction on side initialing the same.
3. Every tender should be accompanied by an amount of Rs.10000/- in case of Chindi Tender. No tender will be considered unless the required amount of deposit is paid by Bank Draft or Pay –in Slip on Bank in the name of \_\_\_\_\_by the tenderer to the mills. The amount of deposit will not carry any interest. .( Cheque /DD in favour of : NTC Ltd, Unit: TATA MILLS)
4. The successful tenderer will have to pay immediately within 24 hours an additional deposit not exceeding 20% of the value of the tender goods, if demanded by the mills.
5. The tender will remain open and valid for 10 days for acceptance from the date and time last mentioned above for submission of tenders.
6. The rates quoted should be ex-mill delivery and will not include GST other duties and taxes in force from time to time and other expenses etc. of whatever nature.
7. The Mills reserve the right to reject any or all the tenders and / or accept, in full or part, the highest or any other tender without assigning any reason whatsoever therefore.
8. No brokerage will be paid on sales of Chindis.
9. The successful tenderers shall have to pay and lift the offered goods within 30 days from the date of the contract.

10. Samples or the qualities of the Chindis can be inspected at the Mills premises between 11.00A.M. and 4.00P.M. on working days.
11. In case of failure of the goods to be paid and lifted as stipulated above against payment of full invoice value by Bank Draft, Bank Pay slip the amount of deposit will be deemed to have been automatically forfeited and the goods will be disposed of on buyer's account and risk by public auction or private sale at the sole discretion of the Mill without notice to the tenderers.
12. The tenders are liable to be rejected if there are any unpaid outstanding bills or dues from the tenderers to the mills.
13. The quantity mentioned in the tender are only approximate. The tenderer must accept the actual quantity at the Mills whether "more or less" and on "as and where is basis".
14. Until and unless a formal contract is prepared and executed, this invitation for tender, the tender and its acceptance with all terms and conditions shall constitute a binding contract between the parties and will further be governed by the terms and conditions of the standard form of contract of the mills which are not inconsistent with or contrary to the conditions stated in this invitation of the tender and its acceptance.
15. No change in the tender will be accepted and the tender containing any change is liable to be summarily rejected.

In case of default of lifting the goods within the period of 15 days from the date of Contract, we agree that the amount of deposit with you will be forfeited and we further agree to pay to you an interest at 18% per annum on the value of the goods from the date of your acceptance together with all godown and insurance charges.
8. We also authorize you to dispose of the goods in case of failure to pay for and take delivery of the goods within seven days from the date of Invoice, to any other party on our behalf and account without notice to us and we agree to pay to you and deficit demanded by you.
