The details scope of work & terms & condition are in the tender form.			

GENERAL TERMS AND CONDITIONS

- All the structures in the mill units shall be inspected block wise and necessary tests carried out as required for our mill situated in Mumbai. The inspection shall cover all the works of engineering, construction, such as building, tanks, scaffolding, platforms, Chimneys, bridges, walls and supporting structural work stipulated by the Chief Inspector of Factories. The tenders may visit the mill, if necessary, to access the scope of work and shall highlight the dangerous portions of the blocks from the safety point of view and suggest remedial
- The inspection shall result in submission of detailed report and measures to strengthen all the weak structures with special emphasis on prevention of collapse in the next five years. Also in the report indicative approximate estimated cost of repair for such job will have to be indicated separately against the structures which are reported to be week and need repair. (However please note that a separate quote is being asked for toward consultation charges for preparations of detailed estimate for necessary repairs jobs to be done as indicated in the stability report).
- The inspection report shall be submitted in the triplicate for the guidance of the mill management.
- The stability certificate in required format as per factory Rules-3 A shall be prepared and submitted to the Factoring inspectorates with a copy to mills, well within the required time of 3 weeks which would be a valid for 5 years i.e. up to May 2029.
- The professional services shall include, obtaining modification of the certificate, as and when required during the next five years, if it is necessitated by any repairs or strengthening measures adopted by the mills to prevent collapse of the structure but shall not include such of modification necessitated by revision of the machinery layout or additions and alterations to structures in future.
- The structural engineer shall give the clarification that may be required by the directorate of industrial safety and health during the period of 5 year.
- The professional charges to be quoted shall be on lumpsum basis and not on the area basis.
- The structural engineer may charge visit fees for any consultation about the structural repairers etc., when called by the mills (Please see Annexure- A).
- It will be endeavor of the mill to extend full co-operation to the consultants in their work and shall try and furnish drawings, structural details etc., as far as possible. But the mill units being old structures, it may not be possible always to furnish such details. In such cases, the consultants will have to ascertain and collect such details on their own.

10. BLOCK PLAN OF THE MILLS

a) Block plan of the mill will be made available to the structural engineering by the mill: During the inspection along with the Engineer of the mill, modification if any, in the block plan may be seen and the up dated block plan shall be furnished by the Structural Engineer. The block plan shall also show the block numbers, number of floors and activity at each floor.

b) It may become necessary in case of insistence by the Factory Inspectors to prepare plans of each block of the mill units as per the requirement of the Factory Inspectors.

11. PAYMENT OF THE PROFESSIONAL CHARGES

- 25% of the payment will be released within 15 days after submission of the report to the office of the factory inspector.
- 55% of the payment will be released after 6 months of the submission of structural certificate.
- Balance 20% will be released in four equal installments of 5% on the 30th November of each successive year for the next five years starting from July 2024.
