## **Terms and Conditions:**

1. In the above quantity of fire extinguishers, 50% of the fire extinguishers should be refilled first and after reinstalling the refilled fire extinguishers, the remaining 50% of the fire extinguishers will be given for refilling.
2. Necessary maintenance of fire extinguishers like replacing of spares, sticker to be done as per Mills requirement.
3. The validity of the fire extinguishers refilling is minimum one year. Within that period, if any fire extinguisher pressure level goes down the standard, it should be refilled on free of cost.
4. Necessary labeling indicating the date of refill and next date of refilling to be done as per existing practice.
5. Bidder should inspect the condition of the fire extinguisher before taking out for refilling. While returning the fire extinguishers, Mills will inspect the condition of the fire extinguisher and if any damages found, it should be replaced with new fire extinguishers by the bidder, on free of cost.
6. The bidder should have at least one year previous experience in refilling and maintenance of the Fire extinguishers in large organization preferably in State / Central Government Organization or in Subsidiary / Public Sector / Semi Government organization.
7. The bidder should have executed work order for refilling and maintaining minimum 50 Nos of fire extinguishers in a single work order.
8. Rates quoted are inclusive of transportation charge and other taxes.
9. Bidder should do all the work themselves. No helpers will be provided by the Mills.
10. Payment should be given only after the satisfactory completion of work.
11. No advance payment will be given.
12. The Bidder has to deposit security deposit (Bank Guarantee) of Rs. 50,000/- (Fifty thousand only) on or before carrying the work, which will not carry out any interest.
13. The Security deposit shall be released without interest after one month of completion of the work and no liabilities from the party.
14. The Bidder shall maintain all statutory registers and submit all returns to the appropriate authorities under the contract labor Act, 1970 and Rules made there under.
15. The Income tax will be deducted at source itself and all other things like Goods and Service tax, PF, ESI will be reimbursed after producing relevant receipts from the concerned authorities as a proof of evidence..
16. The bidder should provide the following Certificates / Documents.
  - a. GST & PAN CardThe bidder should update the validity of the above Documents /Certificates periodically and submit the valid Certificate to the Management for the time being.
17. If registered with MSME/SC-ST .please mention the details along with your quotation.
