Offers without requisite EMD or less than 5% EMD of quoted value shall be rejected. (D.D. should be attached other than co-operative bank).

### **Terms & conditions for sale of Old Used & Unserviceable Metal/Sundry scrap items**

1. Sales shall be effected on 'AS IS WHERE IS BASIS' and "AS IS WHAT IS BASIS".
2. Parties are advised to visit the mills for physical inspection of the scrap. The quotation shall be deemed to have been submitted by the party with full knowledge about the actual condition of the material and no complaints will be entertained after submission of tender.
3. Rates are to be quoted separately for each item as per prescribed unit. **Rates quoted should be exclusive of all Taxes.**(i.e. Taxes extra)
4. Offers must be submitted on our format only. Conditional tenders are likely to be rejected.
5. Quotations received without EMD or less than 5% basic value will be rejected. Earnest Money/Security Deposit payable by Demand Draft/Pay Order only other than Co-operative Bank in favour of NTC LTD., Unit TATA MILLS Quotation received without EMD or less than basic value will be rejected. Earnest Money will be converted into Security Deposit in case of successful tenderer and will be adjusted against the last transaction of the tender.
6. The party to whom the material is sold shall have to deposit entire value by Demand Draft within 20 days of the date of sale letter and obtain delivery order from us, failing which the entire amount of Earnest Money Deposit received against the tender, irrespective of items offered, shall stand forfeited.
7. In case, party fails to execute any one or all sale contracts issued to them or any part thereof the entire amount of Earnest Money Deposit paid shall stand forfeited.
8. The buyer shall lift the material within 30 days from the date of Delivery Order.
9. In case the purchaser even after making the full payment fails to take delivery of the material within stipulated period of 30 days from the date of delivery order, godown rent at the rate of 2% per month on the entire sale value or part thereof will be charged and delivery will be effected only on payment of due godown charges.
10. Wherever the sale is on weight basis, the scrap sold shall be weighed on Mill Weigh Bridge. The weightment shall be done in presence of mill representative and weightment slip shall be signed by both party and mill representative.
11. All taxes/levies/IT prevailing on the day of delivery will be payable extra. GST will be charged extra as applicable at prevailing rates wherever applicable. Parties will have to deposit Income Tax on total sale value at prevailing rate.
12. The purchaser shall be responsible for all damages caused to Mills Property and personnel in course of removal of material.
13. The Mills reserves the right to cancel/retain/change, any item included in tender without assigning any reason thereof.
14. The sale contract shall be subject to Mumbai Jurisdiction.
15. Sale deed is not transferable and resale is not allowed. Party shall have to lift the material by themselves.
16. The Mills reserves the right to accept or reject any tender in full or in part without assigning any reason thereof.
