1. ELIGIBILITY CRITERIA FOR PARTICIPATION IN TENDER.

- a. The bidder should have proven record for conducting satisfactory Job works of minimum 3 Nos of aforesaid work in last three years. The documents of proof for satisfactory completion of the Job work from the respective textile mills are to be enclosed.

- b. The bidder should have valid PAN and also GST. Copies to be enclosed with the tender. Bidder not meeting the above eligibility criteria need not submit tender, otherwise the same shall be rejected summarily.

TERMS & CONDITIONS

- a) Packing materials such as PP Covers, HDPE Bags, Sutly, Bundling labels etc. will be supplied by NTC.
- b) Hard waste should be below 0.3%. The Hard waste/Sweeping Waste generated in the process are to be handed over with proper weight note to us periodically. (ones in every month of the bidder).
- c) The cone yarn packed in bags will be delivered to the conversion area, with properly specifying bag numbers and Net Weight/Gross weight. The bidders are advised to weigh the cone yarn every time before taking in to process to avoid weight shortage issues after conversion (reeling) process. NTC will strictly tally the Quantity of yarn (cone yarn) delivered with the finished yarn (reeled yarn) delivered and waste i.e reconciliation of yarn supplied by us under the contract. In case of any loss of yarn, the cost of yarn cost will be calculated at market price and the said amount will be deducted from bills on settlement of job work charges.
- d) Knots weight, Bundle weight and Bale weight should be within the specified weight and specification given by NTC.
- e) Tie yarn colour should be put as per the instruction given by mills.
- f) The bidders are requested to hand over the cone covers, paper cones, and bags to mills on periodical basis, failing which the actual cost at market rates will be deducted from the bills, on settlement of job work charges.
- g) Since our mill yarn stock will be lying with the bidder during and after conversion the successful bidder is required to submit BANK GUARANTEE for Rs.5 Lakhs, or Payment of equal amount in lieu thereof. The Bank Guarantee will be in the form by us and the same should be issued by any nationalized bank in india and the same should be submitted to our mills before commencement of the job work.
- h) The successful bidder shall permit the mill officials to inspect the goods lying with the bidder at any point of time.
- i) Insurance coverage will be arranged by NTC and the premium will be deducted from the charges payable to the bidder for the job work undertaken.
- j) Payment for the job work will be made once in every month on submission of bills with supply documents.
- k) Work orders should be completed within stipulated period given in the work order at the bidder shall give tentative date of supply of goods after Processing.
- l) Bundle label and chippam bag will be provided by the mills.
- m) Hank should be maintained without free ends and without entanglements.
- n) In case of any Quality Complaints on the processed (reeled) yarn there will be penalty applicable based on the complaints from the customer end.
- o) NTC Will arrange supply of cone yarn at the place of processing and processor has to bear unloading changes.
- p) The processor has to take delivery of cone yarn supplied by NTC by paying unloading charges and also arrange to dispatch the processed yarn (reeled yarn) by paying loading charges.

- q) Transporting charges for outward and inward movement of yarn shall be born by NTC.

3. CORRIGENDUM/AMENDMENTS IN TENDER DOCUMENT

Amendments if any in tender document shall be uploaded in website www.ntcltd.org. Bidders are requested to download the copy of Corrigendum /Amendments from website and attach the same with tender document.

4. APPLICATION COST & EARNEST MONEY DEPOSIT (EMD)

- The prospective bidder has to submit EMD (Earnest Money Deposit) of **_Rs.5000/- and Application Cost of Rs.500/-+ 12% GST= Rs.560/-**. The Demand Draft should be drawn from Nationalized/ scheduled commercial Bank notified by RBI.(Excluding co- operative/Rural Bank).

Demand Draft/ Pay Order are to be in the Name of “ **National Textile Corporation Limited** ” payable at Coimbatore.

- The tender received without EMD shall be rejected out rightly.
- The earnest money deposit of unsuccessful bidder shall be refunded within 15 days by at par cheque on bidder’s demand after completion of process.
- EMD of successful bidder shall be converted into security deposit and will be refunded after completion of contract successfully.

5. Concession/Exemptions for MSEs Entrepreneurs

As per the Gazette of India notification dated 23rd March,2012 the MSEs registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises, are exempt from payment of EMD and the tender cost and concessions therefore, the tenderer to specify whether they are Micro or Small Enterprises and if so whether they are owned by SC/ST Entrepreneurs supported by copies of Registration Certificate issued by the authorities concerned, so as to consider for granting the MSEs necessary concession/exemptions as per Government Directives.

To extend the time of supplies on the part of The General Manager, for said mills by such period as may be necessary to enable The respective General Manager to affect execution after the cause of delays will have ceased to exist. The provisions aforesaid shall not be limited or abrogated by any other terms of the contract whether printed or written.

18. JURISDICTION

All suits or proceedings relating to any dispute or claim arising out of or in course of performance in this contract shall be filed in appropriate court having jurisdiction in the State of Tamil Nadu only.
