National Textile Corporation Limited (W.R.), Mumbai is inviting sealed offers from reputed Contractor / parties for providing and fixing profile pre coated a Tin sheet fencing at India United Mill No.4 as per scope of work.

#### **Eligibility Criteria:**

1. Experience in at least one similar work.(Submit work order / Completion Certificate)
2. G.S.T. registration.( Submit copy of GST registration)

#### **SCOPE OF WORK:-**

1. Providing and fixing vertical M.S. 'I' beam (2"X4"X12') in cement concrete block 1:4:8 mixture in pit size 1½' X1½' X 2' at every 10 R. feet and providing and fixing three horizontal angle of size 2"X2"X5mm thick at equidistance with nuts-bolts/welding. Applying one coat of red oxide and two coat of black oil paint on beam and angle.
2. Fixing profile pre coated sheet 22 SWG i.e. 0.8mm thick, having 10' ft. height. with 'J' bolt etc. complete.

#### **Earnest Money Deposit (EMD)**

6. The Contractor will be responsible to keep the materials i.e. the tools, tackles and materials etc., brought for the said work in your safe custody.

8. PF/ESIC & TDS will be deducted as per prevailing rules.
