*If the delivery is not taken within 30 days from the date of information, the carrying charges @ 3% per month will be imposed & delivery may be taken with carrying charges within 8 days and thereafter the tender will be automatically cancelled and EMD / Security deposit will be forfeited.

*Empty Boras will be charged @ **Rs. 21.00 per Bora** or Empty Boras can be supplied by the party for filling the waste at his own cost and labour. **Bale pressing Charge Rs. 250 / Qtl. will be charged extra for pressed bale form.**

Wvg. Waste Which will be delivered in loose boras form & all other waste are in bale forms.

*The successful tenderer has to lift the material from the Mill godown with their own cost, Risk & Responsibilities.

QUANTITY:

Finlay Mills reserves the rights to hold a certain part of material at any stage of delivery, if it is required by mills. The quantity of Waste offered is tentative & may vary. we have authority to give quantity mentioned plus or minus ten percent as desired by management.
