1) There are cracks in ceiling at 1<sup>st</sup> floor due to water entering in rainy season, so Ceiling repair work is to be done.

2) During rainy season, water entering directly inside the walls from slab therefore cracks are formed on walls & windows, wall plastering is to be done. Some window frame was damaged and some windows were closed with brick plaster which is causing leakage therefore windows need to be repaired /replaced. Distemper /painting work is to be done for repaired jobs.

3) Kitchen and bathroom repairing work is do be done at ground floor. Exhaust fan is to be fitted on 1st floor.

4) Partition of house was made with plywood at first floor which is now damaged, hence getting the partition made with Bakelite sheet (sliding sheet), aluminium, section fitting is to be done.
