INSTRUCTIONS TO BIDDERS

INVITATION FOR BIDS (IFB)

TENDER-CONTRACT FOR SERVICE OF SERVERS, NETWORKING DEVICES, UPS AND VARIOUS BRANDS OF DESKTOP COMPUTERS, LAPTOPS, PRINTERS, SCANNER AND FACILITY MANAGEMENT SERVICES, ON CALL BASIS, REQUIRED FOR NATIONAL TEXTILE CORPORATION LTD. (WRO) MUMBAI, AND ITS UNIT MILLS, MUMBAI.

Terms & Conditions

- 1. The rates quoted should be only Visit charges.
- 2. The rates should be inclusive of all types of taxes & levies like GST etc.
- 3. Only genuine spare parts will be used.
- 4. In case the contracting firm is not able to accept the contract after it is awarded or if they are not able to do any work/undertaken contract the firm will be liable to pay the damage to the NTCWR including the cost, which the NTCWR will have to incur for getting such work done.
- 5. The above act of backing out would automatically debar the contractor from any further dealing with this NTCWR and the security money would be forfeited.
- 6. The payment will be made monthly. The firm shall submit bill along with the call completion report signed by User and concerned HOD by end of the month. The service tax as levied by the Govt. over and above the unit rate/ total amount as admissible, will be payable to the firm. This is only a tentative schedule of payment and does not confer any legal or other right on the firm to proceed against the NTCWR incase payment gets delayed due to budgetary and other unforeseen circumstances. The payment will be made after proper deduction of TDS as per existing rates and rules.
- Technical and Financial bid would be in clear words, categorically mentioning each term specifying the rates etc. Any kind of ambiguous/obscure/unclear terms would lead to rejection of the firm's bid.
- 8. In case the firm falls to cope with the workload or does not render satisfactory services, the contract awarded to them shall be cancelled forthwith and the security deposit and the payments due to them shall be forfeited. The contract can be terminated summarily by this NTCWR at any time without giving any notice or without assigning any reason, if the work of the contractor is found unsatisfactory during the currency of the contract. In this connection the decision of the Head of NTCWR shall be final and binding on the firm.
- 9. NTC reserves the right to award the contract for computer, laptops& printers, etc. on the basis of quotations for each item of work separately or collectively.

10. The duration of AMC contract is for a period of One year and may be further extended in accordance with the requirement of the NTCWR on the same terms and conditions and same rates, if NTCWR is satisfied with the service.

11. (a). Scope of Work

- IT assets covered at NTC Units in this contract are Desktop, Laptop, Printer, Scanner, Server, Firewall, UPS, Network configuration, Networking devices and Projector. Bidders should submit details of qualified manpower on their on-roll, to ensure robust support for the IT assets and IT services. There should be at least One Server engineer & One Networking Engineer (both with minimum 2 years of experience in their respective field), and team of qualified Hardware, Software, Network engineers to ensure proper support for the contract.
- II. Diagnosing and resolving the problem as per the assigned call. For any assigned calls for a system/Equipment, following work to be included in the same call Software installation, Un-installation, configuration, antivirus up- gradation to make system fully functional etc. Installation/updating of O.S, Office, Drivers, supporting software etc. of any device to make the device working. Identifying LAN faults, including LAN configuration, Cable connections and connector replacement etc., to get the issue resolved.
- III. Repair/Replacement of spares and accessories if required and diagnosed by the visiting Engineer may be charged extra, after submission of Quotation by the service provider, subject to the approval from NTC, WRO.
- IV. Call Response Time shall be max 4 hours –Calls assigned by NTC should be attended within 4 hours. Call Response Time in case of critical devices like Server and Networking devices shall be max 3 hours.
