#### **SCOPE OF WORK**

Name of work:

<u>Tender for Fencing Work Using Readymade Cement Pillars at Bengal</u>
<u>Fine Weaving & Spinning Mills, Kataganj, Nadia (A Unit Of National Textile Corporation Limited)</u>

National Textile Corporation Limited invites quotation from eligible and experienced contractors/agencies for the job work of fencing the open boundary of the closed textile mill located at Kataganj, Nadia. The details of the work are as follows:

1) The work involves the supply, installation, and fixing of readymade cement pillars, along with the display of metal sign boards at the specified locations. The following tasks are to be performed:

**Total Length of Boundary to be Fenced:** Approx. 1137 feet

**Number of Cement Pillars Required:** 95 nos.

**Pillar Size:** 4"x4"x6' (Readymade Cement Pillars)

**Installation:** Each pillar must be mounted at least 1 foot under the soil using concrete.

**Metal Sign Boards:** 10 nos.

Size Sign Boards: 1' x 1.5'

The Metal Sign Boards are to be mounted on top of the selected pillars as specified by NTC.

<u>Materials to be Included:</u> 1) Readymade cement pillars; 2) Cement, sand, and stone chips for concrete mounting; 3) Metal sign boards; 4) Labour charges for installation.

#### 2) GENERAL INSTRUCTION TO VENDORS:

- a) Bids are invited and tender document can be downloaded from www.ntcltd.org
- b) The Management reserves the right to reject any or all the tenders or to accept them in part or to reject lowest tender without assigning any reason whatsoever. The Management also reserves the right to call off tender process at any stage without assigning any reason.
- c) The Management reserves the right to reject agencies whose performance at completed/ongoing project(s) is/was below par and unusually poor and has been issued letter of restrain/Temporary/ Permanent debar by any Department. The Management reserves the right to verify the credentials submitted by the firm at any stage (before or after the award of work).

If at any stage, any information/documents submitted by the applicant are found to be incorrect/false or have some discrepancy which disqualifies the firm, then Management shall take action as per Corporation guidelines.

d) Vendors are advised to study the bid document carefully. Submission of the bid shall be deemed to have been done after careful study and examination of all instructions, eligibility, forms, terms and requirement specified in the tender document with full understanding of its implications. Bids not complying with all the given clauses in this tender document are liable to be rejected.

The prospective tenderers may satisfy themselves about the requirements by visiting the Mill (<u>Bengal Fine Weaving & Spinning Mills, Kataganj, Nadia</u>) on any working day (Monday to Friday) between 10.00a.m. And 4.00p.m. before submitting their tenders.

# 3) MINIMUM ELIGIBILITY CRITERIA

#### **Work Experience**

The tenderer should have relevant experience in fencing work or similar civil construction activities. The tenderer must be financially sound and capable of undertaking the work.

#### Note:

The Bidder shall submit details of work executed by them along with bid for the service contract to be considered for qualification of work experienced criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract.

# Following 02(Two) parts shall be submitted by the Vendors:

#### Technical Part: Bids of those Vendors will be opened who will attach below listed documents

- i Valid Establishment Reg. /Incorporation Certificate under Co-operative Societies Act/Shops and Commercial Establishment Act-1961/Indian Companies Act etc.
- ii Bid Security Declaration as per ANNEXURE II
- iii Address proof of Head Office/Branch office located in West Bengal in the name of firm.
- iv Permanent Account Number (PAN).
- v Goods & Service Tax (GST) Registration.
- vi Tender Acceptance Letter as per ANNEXURE III.
- vii Bank Account Details of the Vendors as per **ANNEXURE IV**.

#### NOTE:

i. If any information uploaded by the VENDORS during the bid submission, mismatch with the original document or not available in original document, the VENDORS shall be liable to be debarred from tendering/taking up of work in the Corporation.

ii. If any information furnished by the VENDORS is found incorrect at a later stage also, he/she shall be liable to be debarred from tendering/taking up of work in the Corporation. The Corporation reserves the right to verify the particulars furnished by the applicant independently.

#### **Financial Part of Bid**

- i. Vendors are requested to submit the price part of Bid as per **ANNEXURE-I**.
- ii. All bids shall remain valid for 90 days from the date of publish. A bid valid for a shorter period shall be rejected by the Corporation as non-responsive. In Exceptional circumstances, Corporation may request the Vendors to extend the period of validity.
- iii. LI will be decided by the lowest service charges /total price quoted by the VENDORS. In case service charges/total price quoted by two or more agencies are equal, L1 will be decided by the Management. The decision of management will be final and binding for the purpose of award of work.
- iv. If any information furnished by the applicant is found incorrect at a later stage also, he/she shall be liable to be debarred from tendering/taking up of work in the Corporation. The department reserves the right to verify the particulars furnished by the applicant independently.
- v. The financial part of bid shall be opened only for those Vendors/bidders who qualify the Technical part.

<u>Rate Quotation</u>: The rate should be quoted inclusive of all materials (pillars, cement, sand, stone chips, metal sign boards, etc.), labour, transportation, taxes, and any other charges. Rates should be provided for:

- 1. Supply of 95 readymade cement pillars (4"x4"x6').
- 2. Installation cost, including concrete mounting at 1-foot depth under soil.
- 3. Supply and installation of 10 metal sign boards (1' x 1.5') on top of pillars.
- 4. Any additional charges to be mentioned separately.

#### 4) VALIDITY OF OFFER:

The Tenderer shall keep the offer open for a minimum period of 90 days from the date of opening of the tender within which period the tenderer cannot withdraw his offer, subject to the period being extended further if required by mutual agreement from time to time. Any contravention of the above condition will make the tenderer liable for penalty.

# 5) EARNEST MONEY DEPOSIT (EMD)

Earnest Money Deposit {EMD}: As per OM No. F.9/4/ 2020-PDD dated 12.11.2020 of Procurement Policy Division of Department of Expenditure under Ministry of Finance, in place of Bid Security; Bidders are required to sign a **Bid Security Declaration (Refer. ANNEXURE II)** accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of time specified in the request for bids document from being eligible to submit Bids for contracts with the entity that invited the Bids.

# 6) PAYMENT TERMS & BILLS:

- a) Bills will be prepared in triplicate by the contractor and submitted to the office. No interest will be paid by the Mill management for delay in submission of bills. On account payment will be made to the firm/contractor.
- b) All the statutory documents should be enclosed with the bills. The payment will be released to him after deduction of Income tax, GST, TDS or any other statutory dues.

# 7) **FORCEMAJURE**

The Unit In charge Of respective Mills shall not be liable for any failure or delay in execution of contract due to any cause beyond their control including fire, floods, strikes, go-slow, lock-out, closure, pestilence, dissilience, dispute with staff dislocation of normal working conditions, war riots, epidemics, political upheavals, Government actions commotion, breakdown of machinery, shortage of labour, demands or otherwise or any other cause or conditions beyond the control of aforesaid causes or not and the existence of such cause or consequence may operate at the sole discretion of The Unit In charge Of respective Mills . To extend the time of execution on the part of The Unit In charge of respective Mills by such period as may be necessary to enable the respective Unit In charge to effect execution after the cause of delays will have ceased to exist. The provisions aforesaid shall not be limited or abrogated by any other terms of the contract whether printed or written.

# 8) ARBITRATION

Any dispute or differences what so ever any of the parties hereto, which may at any time hereafter arise during the continuance or termination of his arrangements / contract touching and / or concerning this arrangement/contract, its construction or effect, the rights, duties or obligations of the parties hereto or any other matter in any way connected with or arising out of this arrangement shall be referred to the arbitration of arbitrator to be appointed by BF2. It will be no objection that the person so appointed is or was in the employment of the corporation had during the 17 course of his duties expressed views on all or any of the matter in difference in dispute. The arbitration proceeding shall be held in accordance with and subject to provisions of Arbitrations and Conciliation Act, 1996 or any statutory modification / substitution or enactment thereof for the time being in force. The place of arbitration shall be at Kolkata. The English language shall be the language of arbitration and used throughout the arbitration proceedings. The Arbitrator shall have the summary power. The award passed by the Arbitrator shall be final and binding on both the parties.
