The contractor has to carry out the job as per the instruction of engineer of Podar Mills after completion of job, satisfactory submit the monthly bills in duplicate duly certified by the Engineer.

Payment Terms

- I. No advance payment shall be made.
- II. 100% Payment will be released after completion of satisfactorily work and Bill certified by the Podar Mills user department on monthly basis.

Liquidated damages for Delay

0.05% of contract price per week or part thereof subject to a maximum of 5% of the total contract value will be counted after 7 days from the date of confirm order.
