The parties interested are required to submit following documents along with their offer : -

  - II. IT return of the firm for one year .
  - III. Pan Card.
  - IV. Name of the contact person.
  - V. Contact Number
  - VI. The details of last year yarn transaction with Textile commissioner office if any.
- The party should ensure that the mill from where the HYO is transferred should have packed hank yarn more than its own Hank Yarn Packing Obligation and submitted the quarterly returns in Annexure 1 within the due date prescribed under Hank Yarn Packing Notification 2003.

- The transferor mill should have fulfilled all the requirements formalities prescribed under Hank Yarn Packing Obligation Notification and here should not be any dis-qualification for transfer under any ground.
- It is the responsibility of the agent to forward the valid documents for such transfer and if any objection on the transfer is raised by the O/o Tex Commissioner, it is the
- responsibility of the agency to clarify and convince them for getting valid transfer of HYO.
- The party has to thus send the transfer application duly certified by the Chartered Accountant for the further action by the unit under NTC WRO/ WRO Office. And after the satisfied completion of fulfillment of Hank Yarn Obligation , the relevant payment shall be released.
- In all the above cases the decision taken by NTC Ltd., WRO, Mumbai would be binding on both the parties.
- As a part of the responsibility the parties would be required to interact / liaise with the TCO for the issues related to an / or relaxation the HYO fulfillment norms with regards to the fulfillment of the past obligations.
- Parties have to quote for the mill wise entire quantity only.
- Jurisdiction: The transactions and disputes arising of the contracts entered between the agents and Mills shall be subject to the court jurisdiction of Mumbai.
- NTC has right to reject or accept the rates.
