## **TERMS & CONDITIONS:**

- 1) The party will have to use their own tools and gadgets required for the job including scaffolding, if required
- 2) The party will have to furnish their Registration Certificate of Contract.
- 3) All the statutory dues viz. **ESIC**, **PF**, **IT**, as applicable will have to be borne by the party. Party will have to obtain Insurance Policy under Workmen Compensation Act, covering party's all workers for accident/injury while carrying / outside job in Mills. The party will be solely responsible as well liable for any accident/injury of their workers.
- 4) The Job to be carried out without any damage to the mill's property. In case of damage, in any form, the losses on such account to the mills, shall be recovered from party's bill.
- 5) The party will have to make entry of the name of their employees in Mill gate Register regularly during the period of work.
- 6) The party should execute the said job under the supervision / guidance of mill Engineer.
- 7) Payment Terms: The payment will be made on after complication of the job certified by concern Department Incharge.
- 8) In case, the job is not being carried out as per the terms of Tender, in that circum stance, the EMD & value of completed work will be forfeited.
- 9) In case, the party leaves the job in between, under such circumstances, the job will entrusted to the other party and the differential amount incurred for carrying out the left out job work will be recovered from the defaulting party.
- 10) Party should submit E.M.D. of Rs. 5000/- by way of D.D. pay order from any Nationalized/ Scheduled, Multi-Scheduled commercials Bank in favour of NTC Ltd., Unit India United Mill No. 5.
- 11) Only water and electricity supply by mill.
