Eligibility Criteria:

1. Experience in at least one similar work in last 3 years (submit copy of work order)
2. G.S.T. registration certificate (submit GST registration copy).

Earnest Money Deposit (EMD)

The Bidder should submit an EMD of Rs. 5,000/- (Rupees Five Thousand only) in form of Demand Draft drawn from any Nationalised Bank / Commercial Scheduled Bank (Except Co-Operative Bank), in favour of "**N.T.C. Ltd.- Unit-Western Region**" payable at Mumbai.

EMD of successful bidder will be converted into Security Deposit and will be return after completion of work successfully and shall not carry any interest.

EMD of unsuccessful bidder will be return after finalization contract and shall not carry any interest.

PERIOD OF COMPLETION

The contractor will take immediate effort to start the work after received confirm order and ensure that the entire job should be completed within 45 working days.

CERTIFICATION OF WORK

The contractor has to carry out the job as per the instruction of engineer of corporate office after completion of job satisfactory submit the bill in duplicate along with attendance of your worker in gate for same job. Bill will not be accepted unless & until the above said documents are not along with the Bills. The bills duly certified by the Corporate Engineer.

Payment Terms:

- I) No advance payment shall be made.
- II) 100% Payment will be released after completion of satisfactorily work and Bill certified by the Corporate Engineer.

Liquidated damages for Delay

0.05 % of contract price per week or part thereof subject to a maximum of 5% of the total contract value will be count after 60 days from the date of confirm order.

Terms & Conditions:

1. Demand Draft for EMD and Cost of tender document should be drawn from Nationalised / Commercial Scheduled Bank. The tender will be **Rejected** out rightly if Demand Draft of **CO-Operative Bank** or **incomplete name of the beneficiary.**
2. The contractor has to carry out the job as per the instruction of Corporate Engineer.
3. The contractor will take all necessary precaution to prevent any damage to the property of the office. If any damage caused during the course of work will be repair the damage at your own cost on priority basis otherwise the repair cost will be recovered from your bill.
4. Debris & Salvage materials arising out of dismantling work shall be removed from the site and stacked in the proper place as directed by Engineer.
5. The Contractor will use your own tools & tackles including gas cutter, welding machine etc and work force.
6. The Contractor will be responsible to keep the materials i.e. the tools, tackles and machines etc., brought for the said work in your safe custody.
7. The Contractor will abide by the all the labour rules & regulations as applicable from time to time.
8. PF/ESIC will be deducted from your bill amount as per prevailing rules. If you have paid the ESIC & PF of your employees, please submit the supporting document with the bills.
9. Income Tax and other Taxes as applicable during the contract period shall be deducted from your bill as per the rule applicable from time to time.
10. The Contractor will be in responsible to provide necessary insurance cover to your workers as may be required under the law.

11. The Contractor will be fully responsible for any compensation either for accident, injury /death or damage caused during the operation to their employee/s.
12. NTC-WRO can terminate the contract at any point of time without assigning any reason thereof.

1.	<p>Removal of damaged patches of plaster and re-plastering surface: Providing and applying sand faced plaster in CM 1:4 (1 cement : 4 sand) of average thickness of 25 mm in two coats (first coat of 16 mm thickness and final coat of 9 mm thickness) with integral water proofing compound at 2% by weight of cement and with polymer bonding agent at 300ml/50Kg of cement for every layer of application including making grooves of existing sized, including removal of the old damaged/loose/debonded plaster. The plastering shall be done on brick work, concrete surface, Pillars of wall etc. The exposed joints (of masonry or of concrete) shall be raked out to a minimum depth of 10 mm uniformly with proper raking tool and tackles before plastering. The surface shall be finally finished with neat cement slurry flushing coat for smooth finish.</p> <p>The plaster has to be done in patches (square or rectangular shape) or stretches or on and to match the adjoining surfaces, sealing the minor crack in plaster with suitable polymer crack seal as necessary at all levels. One coat of primar and one coat of distemper. Disposing off the debris outside NTC premises, cleaning the area thoroughly. The work includes costs of all materials, scaffolding charges, labour charges, curing etc. Complete.</p>	280 Sq. ft.
