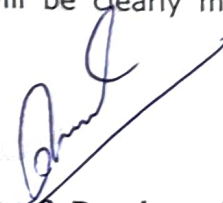

Terms & Conditions

The bidder shall carefully read and comply with the following terms and conditions while submitting the quotation:

1. Scope of Work

The rate contract shall include preventive and breakdown maintenance as well as supply of spares/material of the complete CCTV surveillance system at Finlay Mills, Achalpur.

2. Contract Period :- The Rate Contract shall be valid for a period of **one year** from the date of issue of the work order and may be extended based on satisfactory performance and mutual agreement.

3. Breakdown Maintenance :- The contractor shall attend all breakdown complaints during the contract period.

a. Maximum response time shall be **within 24 hours** from the time of complaint.

b. Critical faults shall be rectified as early as possible, preferably within **72 hours**, subject to the availability of spare parts.

4. Spare Parts :- Replacement of defective spare parts shall be carried out only after obtaining written approval from the Mill. Rates of commonly used spare parts shall be submitted separately.

5. Qualified Personnel :- The contractor shall deploy experienced and technically qualified personnel for maintenance work and shall ensure compliance with all applicable safety regulations.

6. Site Visit :- Bidders are advised to visit the factory site before submitting the quotation to assess the existing CCTV system and maintenance requirements. No additional claim arising from lack of site inspection shall be entertained.

7. Tools and Equipment :- The contractor shall provide all necessary tools, testing instruments, ladders, and equipment required for carrying out maintenance work.

8. Safety Requirements :- The contractor shall comply with all factory safety rules and regulations. Personnel shall wear appropriate Personal Protective Equipment (PPE) while working inside the factory premises.

9. Payment Terms :- Payment shall be made on a **monthly basis after satisfactory completion of services**, unless otherwise specified. Applicable statutory deductions such as TDS shall be made as per government rules. GST shall be indicated separately in the quotation.

10. Penalty Clause :- Failure to attend complaints or complete maintenance within the stipulated time may attract a penalty as decided by the mill management and may result in termination of the contract.

11. Replacement of Equipment :- The contractor shall immediately inform the mill in writing if any equipment is found beyond economical repair. Replacement shall be carried out only after written approval from the factory.

12. Records :- The contractor shall maintain a logbook of all preventive maintenance visits, complaints attended, repairs carried out, and spare parts replaced.

13. Validity of Quotation :- The quotation shall remain valid for a minimum period of **90 days** from the date of submission.

14. Mill Rights :- The mill reserves the right to: (1) Accept or reject any or all quotations without assigning any reason. (2) Cancel the tender process at any stage. (3) Award the contract wholly or partly to one or more bidders.

15. Compliance :- The successful bidder shall comply with all applicable labour laws, statutory requirements, insurance obligations, and other legal provisions during the contract period.

16. Jurisdiction :- Any dispute arising out of this contract shall be subject to the jurisdiction of the competent courts where the factory is located.
