1. Service on call Basis unlimited.
2. Technician should visit every month for preventive Maintenance works.
3. The fault shall be attended within 6 hours of reporting / logging of call or latest by the next working day. All calls should be attended for EPABX, wire and Telephone sets
4. If wiring, damage of telephone instrument and cord is burnt due to electric or earthing will be paid extra.
5. In the event of withdrawing the offer by the contractor at any stage from date of placing order OR if the Job is not carried out to the satisfaction then contract will be terminated with 15 days notice, pending payments of the contractor shall be forfeited
6. Income Tax and any other tax applicable during the execution period shall be deducted from contractor running bill as per rule applicable at the time of execution of work and certificate to this effect shall be issued by WRO.

- C. Payment will be released within 15 days from the date of submission of bills.


JURISDICTION
