- 4. If wiring, damage of telephone instrument and cord is burnt due to electric or earthing will be paid extra.
- 5. In the event of withdrawing the offer by the contractor at any stage from date of placing order OR if the Job is not carried out to the satisfaction then contract will be terminated with 15 days notice, pending payments of the contractor shall be forfeited
- 6. Income Tax and any other tax applicable during the execution period shall be deducted from contractor running bill as per rule applicable at the time of execution of work and certificate to this effect shall be issued by WRO.
