#### **Preamble**

The Principal intends to award, under laid down organizational procedures, contract/s for to The Principal Values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/ transparency in its relations with its Bidder(s) and/or Contractor(s).

In order to achieve the se goals ,the Principal will appoint an Independent External Monitor(IEM),who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

#### Section1-CommitmentsofthePrincipal

- 1. The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:-
- a.No employee of the Principal, personally or through family members, will in connection
  withthetenderforortheexecutionofacontract, demand, takea promise for oraccept,
  for selforthird person, any material or immaterial benefit which the person is not legally entitled to.
- b. The Principal will, during the tender process treat all Bidder(s) with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.
  - c. The Principal will exclude from the process all known pre judiced persons.
  - 2. If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the IPC/PC Act, or if there be a substantive suspicion in this regard, the Principal will inform the Chief Vigilance Officer and in addition can initiate disciplinary actions.

#### Section2-CommitmentsoftheBidder(s)/contractor(s)

1. The Bidder(s)/Contractor(s) commit themselves to take all measures necessary to prevent corruption.

- He commits himself to observe the following principles during his participation in the tender process and during the contract execution.
- a.The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promiseorgivetoanyofthePrincipal'semployeesinvolvedinthetenderprocessorthe executionofthecontractortoanythirdpersonanymaterialorotherbenefitwhichhe/sheisnot legallyentitledto,inordertoobtaininexchangeanyadvantageofanykind whatsoever during the tender process or during the execution of the contract.
- b.The Bidder(s)/ Contractor(s) will not enter with other Bidders into any undisclosed agreementorunderstanding,whetherformalorinformal. This applies in particular to
  - prices, specifications, certifications, subsidiary contracts, submission or non-submission of bidsorany other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- c.The Bidder(s/Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s)/ contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- d.The Bidder (s)/Contractors(s) off or reign origin shall disclose the name and address of the Agents/ representatives in India, if any. Similarly the Bidder(s)/Contractors(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. Further detailsasmentionedinthe "GuidelinesonIndianAgentsofForeignSuppliers" shall be disclosed by the Bidder(s)/ Contractor(s). Further, as mentioned in the Guidelines all the payments made to the Indian agent/ representative have to be in Indian Rupees only. Copy of the "Guidelines on Indian Agents of Foreign Suppliers" is placed at Annexure- B1.
- e.The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payment she has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- 2)The Bidder(s)/Contractor(s)will not in stigatethird persons to commit offences out lineda bove or be an accessory to such offences.

#### Section3- Disqualificationfromtenderprocessandexclusionfromfuturecontracts.

If the Bidder(s)/Contractor(s), before award or during the execution has committed a transgressionthroughaviolationofSection2,aboveorinanyotherformsuchastoputhis reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s)/Contractor(s) from the tender process or take action as per the procedure mentionedinthe "GuidelinesonBanningofBusinessDealings". Copyofthe "Guidelines on Banning of Business Dealings" is annexed and marked as Annexure-B2.

#### Section4-CompensationforDamages

1.If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit / Bid Security.

2.If the Principal has terminated the contract according to Section 3, or if the Principal is entitledtoterminatethecontractaccordingtosection3, the Principal shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

### Section5-Previoustransgression

- 1. The Bidder declares that no previous transgressions occurred in the last three years with any other Company in any country conforming to the anti- corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- 2. If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or action can be taken as per the procedure mentioned in "Guidelines on Banning of Business Dealings."

#### Section6-EqualtreatmentofallBidders/Contractors/Subcontractors

- 1. The Bidder(s)/Contractor(s)undertake(s)to demand from his sub-contractors acommitment in conformity with this Integrity Pact.
- 2. The Principal will enter into a greements with identical conditions as this one with all Bidders and Contractors.
- 3. The Principal will disqualify from the tender process all bidders who do not sign this Pactor violate its provisions.

# Section 7 – Criminal charges against violating Bidder(s) / Contractor(s) / Subcontractor(s) If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Sub contractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

#### Section8-IndependentExternalMonitor/Monitors

- 1.The Principal appoints competent and credible Independent External Monitor for this Pact. The task of the Monitor is tore view independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- 2. The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. It will be obligatory for him to treat the information and document soft the Bidder(s)/Contractors as confidential. Here ports to the Chairman, NTC.
- 3.The Bidder(s)/ Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/ Contractor(s)/ Subcontractor(s) with confidentiality.
- 4. The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.

- 4.As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit nonbinding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in as pecific manner, refrain from action or tolerate action.
- 6.TheMonitorwillsubmitawrittenreporttotheChairman,NTCwithin8to10weeksfrom thedateofreferenceorintimationtohimbythe*Principal*and,shouldtheoccasionarise,submit proposals for correcting problematic situations.
- 7.IftheMonitorhasreportedtotheChairman,NTC,asubstantiatedsuspicionofanoffence under relevant IPC/PC Act, and the Chairman NTC has not, within there as on able time takenvisibleactiontoproceedagainstsuchoffenceorreportedittotheChiefVigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- 8. The word 'Monitor' would include both singular and plural. Monitor would be entitled to receive such compensation as may be decided time to time by the CMD/Competent Authority.

#### Section9-PactDuration

This Pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the contract or contract period (extended if applicable) whichever is later and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/lodged during this time ,the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by Chairman of NTC.

#### Section10-Otherprovisions

- 1.ThisagreementissubjecttoIndianLaw.Placeofperformanceandjurisdictionisthe Registered Office of the Principal, i.e. New Delhi.
- 2.Changes and supplements as well astermination notice sneedtobe made in writing. Side agreements have not been made.
- 3.If the Contractor is a partner ship or a consortium, this agreement must be signed by all partners or consortium members.
- 4. Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 5.IntheeventofanycontradictionbetweentheIntegrityPactanditsAnnexure,theClauseinthe Integrity Pact will prevail."
