1	<p>Removal of rank vegetation on mill building & premises & underground gutter cleaning- 2025</p> <p>Removal of rank vegetation (unwanted trees, branches, bushes etc. on wall). To inspect the mill premises and make the location of rank vegetation grown up on walls, scaffolding, safety, compound etc. Provide safety by cutting the same. If the wall gate damaged at the time of removal of vegetation the same to be patched/ repaired with cement, sand mixed and protected. Apply hydraulic acid to the root of the vegetation to prevent the further growth in future.</p> <p>To clean all the underground main gutters and small gutters in the mill building & premises. To take out all the abstractions from the gutters. To make the water flow easy from the mill gutters to the BMC gutter upto the main gate of the mill. The contractor/ contract workers to remain present in the mills and will take care of choking of gutters and water flow in the monsoon period from June 2025.to Sept.2025. The contractor will bring all the tools and safety gadgets. The job to be carried out with taking complete safety precautions while working on height. All required tools and safety belt etc. for the job is to be brought by the party itself. All safety precautions of workers & building is to be taken.</p>
